## **Rules of the Game**

- Trading will commence with the ring of a bell and continue for 30 minutes. After a 15-minute break, trading will resume for another 30 minutes and finish at the ring of a bell. Each trading day will last for 60 seconds; there are 60 total trading days.
- Every team of four will begin with \$1,000,000.
- Fictitious company names, three letter stock symbols, and a brief description are provided to enable teams to identify the 26 stocks available. Each company's name begins with a different letter of the alphabet
- Floor traders with tablets come to tables to take trading orders.
- Two large screens will display different aspects of the game. To track your team's stock portfolio and progress, portfolio statements are available for the team from the printing stations.
- All trades will be subject to a trading commission of 1.25%, which will be automatically deducted from the team's total.
- Hot Tips and Newsletters will be released throughout that contain hints or suggestions as to which way specific stocks will turn.
